**Subject : Enhancement of wage ceiling from Rs. 6,500 to 15,000 – urgent need of preparatory activities- additional instructions- regarding.**

Sir,

This is in continuation to the instructions issued vide this office letter dated 14.07.2014 (placed at Sl. No. 268 in the circular segment of the official website for the year, 2014-15).

2. The following additional instructions are issued in connection with the preparatory activities before notification on enhancement in statutory wage ceiling for enrolment under the EPF & MP Act 1952 to Rs. 15,000/- per month from the current maximum of Rs. 6,500/- per month is issued :

- a) The details of visible establishments like hospitals, diagnostic centers, maternity centers, hotels, restaurants, schools, workshops, show rooms of branded companies etc. be listed out by the area Enforcement Officers in duplicate and a copy may be submitted to the Regional Provident Fund Commissioners, In-Charge of Regional/Sub Regional Offices by 31<sup>st</sup> August, 2014;
- b) The details of franchises and service centers of manufacturers of branded electronic appliances, dish antenna providers shall be collected by the Enforcement Officer to verify their compliance position;
- c) The list of covered and uncovered establishments may be prepared Enforcement Officer-wise. The reasons for non-coverage of all the eligible establishments be analyzed by Regional Provident Fund Commissioners, In-Charge of Regional/Sub Regional Offices;
- d) The Regional Provident Fund Commissioners, In-Charge of Regional/Sub Regional Offices will designate one Assistant Provident Fund Commissioners who shall regularly go through the advertisements appearing in the newspapers both in local language and English to see as to whether there are any potential information for the purpose of coverage. They will pass on the intelligence so gathered to the area Enforcement Officers to verify the coverability of new establishments. After verification, if the establishments are found coverable, they will pass on the proposals to the Regional Provident Fund Commissioners, In-Charge of Regional/Sub Regional Offices for coverage; and
- e) Regional Provident Fund Commissioners, In-Charge of Regional/Sub Regional Offices shall devise appropriate mechanism to explore the possibility of coverage of new establishments under the Act.
